**Savings account types pay interest at quarterly intervals, and monthly for all Money Market account types, when applicable. Savings and Money Market accounts types must maintain minimum daily balance to earn interest. Interest is calculated on Average Daily Balance during any statement cycle.

***Certificate of Deposit - Interest is paid at maturity for 12-month or less CD term, or annually for 24-month or longer CD term

Certificate of Deposit rates are negotiable with a minimum deposit amount of \$250,000.00 and a minimum term of 12 months
