Fiafia Checking - \$10.00 monthly checking account credit applied when all stipulations are met (45 days to establish Direct Deposit)

Stipulations and required services to earn monthly credit:

- Direct Deposit**
- \$100.00 minimum daily balance
- No in-bank withdrawals**
- TBAS Mastercard Debit Card (free)
- Electronic Banking Services (free)

- Checks are not allowed for this account type

Territorial Checking - \$5.00 monthly Service Fee waived with Direct Deposit (45 days to establish Direct Deposit), or Mobile Remote Deposit (at least 1 per month), or by maintaining a \$100.00 minimum daily balance

Priority Checking (Senior 55+) - \$3.00 monthly Service Fee waived with daily minimum balance of \$100.00

Fanau Savings - \$2.00 monthly Service Fee waived with \$100.00 daily minimum balance

Atamai Savings - \$4.00 monthly Service Fee waived with \$200.00 daily minimum balance

Money Market - \$5.00 monthly Service Fee waived with \$1,000.00 daily minimum balance

TBAS Business Account Types

Commercial Checking*** (refer to Account Analysis Fee structure)

Small Business Checking - \$25.00 Monthly Service Fee waived with a daily minimum balance of \$500.00 and;

- Account has no more than 20 deposit transactions in a month
- Account has no more than 20 inclearing checks in a month (electronic items are unlimited)

Non-Profit Checking - \$6.00 monthly Service Fee waived with a daily minimum balance of \$500.00

Business Money Market (Savings or Checking) - \$10.00 monthly Service Fee waived with daily minimum balance of \$5,000.00

**\$50.00 minimum deposit required to open or re-open and account. Initial deposit will be placed on hold for a period of 180 days from the time the initial deposit is made.*

***If Direct Deposit is not received, or in-bank withdrawal is conducted in any month, a \$10.00 Service Fee will be assessed to the account.*
